Registration

- A. The deadline for submitting registration forms expires on **15 April 2020, 23:59 UTC+1**
- B. Candidates will be informed about the results before **17 May 2020**
- C. The qualification process is conducted by an internal committee, which awards points after evaluating submitted video files.
- D. The committee may award additional points if a performance's planned world premiere is going to take place during the Festival.
- E. Performing groups from abroad that have been qualified for the Festival are supposed to send in a confirmation of being awarded appropriate visas **before 31 July 2020**. If this requirement is not met, the group is going to be removed from the list.

Requirements

- A. The performance duration must not exceed **70 minutes**.
- B. Time required for preparing the scenography must not exceed **60 minutes**, while derigging and other activities related to dismantling of the scenography have to take **less than half an hour**.
- C. Groups may be registered either by using the online registration system or by sending a completed form to festiwal.pro.contra@gmail.com. It is also possible to register by sending a form through conventional mail to:

- D. A complete application should contain, apart from the form itself:
 - At least 3 photos with quality appropriate for press publishing;
 - Video file with the recording of the play - please note that the play should be recorded in one take without zooming, cuts or post-processing;
 - A short trailer or advertisement of the play (up to **30 seconds**).

Additional info for the groups

- A. The organiser provides food and accomodation solely for **up to 5 members** of the group during the whole Festival (for Friday, Saturday and Sunday). If a group would like to have more members accomodated (with meals included), it is required to cover a fee of **65 zlotys** per person per day.
- B. The organiser does not cover costs related to travel.
- C. If the groups withdraws from participating in the Festival **after 31 July 2020** without a valid and important reason, the members are required to **cover the accomodation and catering costs.**

Prizes and awards.

Grand Prix PRO CONTRA 2020 – awarded to one group after audience voting.

Best Actor - awarded by the qualifying committee

Best Actress - awarded by the qualifying committee

Artistic Director's Award – awarded by the Artistic Director, Tatiana Malinowska-Tyszkiewicz.

Each group will receive a **Certificate of Participation.**
